



多溴聯苯/多溴聯苯醚分析流程圖 / Analytical flow chart - PBBs/PBDEs









六溴環十二烷分析流程圖 / Analytical flow chart - HBCDD







全氟辛酸/全氟辛烷磺酸分析流程圖 / Analytical flow chart - PFOA/PFOS








